Please find attached our quotation for the above referenced project. All items are quoted per project plans, stamped, and signed 6/17/2024, by the civil engineer, for "Public Street Improvement Plans for Blue Parkway" located in Lee's Summit Jackson County, MO.

Bid Proposal Price: \$167,134.00 (LUMP SUM)

Conditions & Exclusions:

- Our proposal is based on our entering into a subcontract in a form mutually satisfactory to both parties.
- Price based on Capital Electric being provided reasonable time, access and notification to install the Street Lighting Conduits under paved surfaces, prior to the installation of roads, paved surfaces, sidewalks, drive approaches, hardscapes, etc.
- A performance, maintenance, and/ or payment bond are **INCLUDED**.
- City Inspection Fees and Permits are **EXCLUDED**. The Developer shall typically pay for all scopes of work from all contractors to avoid additional mark-up. Capital Electric Line Builders, LLC shall not be held responsible for any payment for inspection fees or permits for the project referenced above.
- Complete payment will be made upon completion of work and acceptance by the City of Lee's Summit, MO, with zero percent (0%) retainage held.
- This proposal will be valid for Sixty (60) days from the bid date. After
 Sixty (60) days, we shall have the right to re-quote. It is imperative that
 we be notified as soon as possible after the award of the project of your
 intent to award us the work. Extreme volatility in material pricing
 requires that we secure material orders as soon as possible, so we can
 hold our pricing.
- The following items are **EXCLUDED**:
 - Sales Taxes.
 - Rock Excavation. If encountered, up to \$12.00 per lineal foot of rock trenching, boring, or excavating will be added to the contract price.
 - Hauling of spoils.
 - Sodding, seeding, landscaping or final surface restoration.
 - Damage to silt fence if installed within five (5) feet of the proposed working area for all work related to the installation of all Street Lighting Material and Equipment.

- Sidewalk, curb, and gutter repair or replacement, street surface restoration.
- Any City Permit & Inspection Fees.
- Traffic control, traffic marking and traffic signing.
- Removal or adjustment of any existing utilities.
- Erosion Control/SWPPP.
