1. INSURANCE REQUIREMENTS:

Before commencing the Subcontract work, and for the duration of the project, Subcontractor must provide certificates of insurance naming Horizon Retail Construction, Inc as an additional insured on a primary and non-contributory basis, for Commercial General Liability policy and Commercial Automobile policy. The general liability policy shall utilize ISO Form CG 20 10 04/13 and CG 20 37 04/13 or the equivalent. The insurance afforded to the additional insured shall be at least as broad as that afforded to the first named insured. All policies shall also contain a waiver of subrogation in favor of Contractor, tenant, landlord and owner. Policies shall provide for at least (30) thirty days' notice of cancellation of any insurance to contractor. Such coverage shall be maintained in form and with companies having a minimum AM Best rating of A- VII. Subcontractor shall purchase and maintain insurance having the minimum limits:

- (a) Comprehensive General Liability Insurance Each occurrence limit \$1,000,000 or full per occurrence limit of the policy, whichever is greater, Personal and advertising injury limit \$1,000,000, Fire damage limit \$100,000, Products completed operations aggregate limit \$2,000,000, General aggregate limit \$2,000,000, Medical expenses, any one person \$5,000. Horizon Retail Construction, Inc. must be additional insured and Certificate Holder.
- (b) Comprehensive Automobile Liability Insurance Combined single limit \$1,000,000 for property damage and bodily injury. Policy must include coverage for non-owned automobile liability coverage and hired vehicle coverage. Horizon Retail Construction, Inc. must be additional insured and Certificate Holder.
- (c) Workers Compensation Insurance A workers compensation policy shall be in-force with limits of \$500,000 bodily injury per incident & \$500,000 bodily injury by disease policy limit. The State in which work is being performed must be a covered State on the workers compensation policy and shown on the certificate of insurance. Coverage must be extended to include sole proprietors, partners, and executive officers. Horizon Retail Construction, Inc. must be Certificate Holder.

2. INDEMNITY

To the fullest extent permitted by law, the Subcontractor shall defend, indemnify and hold harmless the Contractor, Landlord, Tenant and the Owner, their agents, consultants, and employees from any and all claims arising out of the Subcontractors work or anyone employed directly or indirectly by any of them or by anyone for whose acts any of them may be liable.

3. WAIVER OF SUBROGATION

The Contractor and Subcontractor waive all rights against each other, the Owner, Landlord, Tenant and the Architect/Engineer, and any of their respective consultants, subcontractors and sub-subcontractors, agents and employees, to recover damages to the extent covered and paid by the proceeds of a builder's risk policy, excluding such rights as they may have to receive such insurance proceeds. Subcontractor shall require similar waivers from its Vendors.

4. LIENS/LIEN WAIVERS

As a condition to any payment, including progress payments and final payment, Subcontractor shall deliver to Contractor all executed and notarized waivers of all lien rights for all work, equipment, labor, services, supplies and materials. Contractor may withhold payment to Subcontractor until all such executed lien waivers have been received by Contractor. Subcontractor shall defend, indemnify and hold harmless the Contractor, its sureties, and the Owner, from any and all liens or other claims for payment, made or asserted by any third person alleging or claiming non-payment for work, labor, materials, equipment, or services furnished or performed as part of Subcontractor's work. Subcontractor shall, at its own expense, promptly discharge, satisfy or remove any and all such liens by payment, bonding, or other means.

5. SAFETY RULES/REGULATIONS

All representatives of your company, who are on the jobsite, MUST sign in, upon arrival, and sign out, upon departure confirming they are

leaving the jobsite with no injuries, with the site superintendent using "Sign In/Sign Out Form" EVERY day. Subcontractor must provide and require all representatives to always wear proper PPE.

Subcontractor agrees to be responsible that its agents, representatives, employees, and suppliers comply with all safety requirements. The work is to be pursued in a safe manner at all times taking all necessary precautions to avoid injuries to the public and to the workmen. All laws, ordinances, codes, rules and regulations relative to safety and the prevention of accidents shall be complied with as well as the Occupational Safety & Health Act of 1970, as amended. The Subcontractor does assume all responsibilities of Horizon Retail Construction, Inc. with respect to the work under this Construction Contracts, and indemnifies and holds Horizon Retail Construction, Inc. harmless from all penalties, damages or other losses resulting from failure of subcontractor and those for whom it is responsible to comply with this paragraph. Possession, distribution, or consumption of alcohol and/or illegal drugs is prohibited on the jobsite. Reporting to work under the influence of alcohol or illegal drugs is not permitted. If a subcontractor employee is determined to have breached the terms and conditions of Horizon Retail Construction, Inc.'s alcohol and illegal drug policy, the employee in question shall be removed from the site immediately, and will not be allowed back on the site without express written permission by Horizon Retail Construction, Inc.

6. DELIVERY AND MATERIAL MANAGEMENT

Subcontractor agrees to take responsibility of all materials, whether Owner supplied, or Subcontractor provided as it relates to their scope of work. This includes, but is not limited to, ordering, inventory, inspecting, delivery, and unloading of all material from the closest point of delivery to the final installation.

7. WARRANTIES

Subcontractor warrants that all materials furnished under this Agreement shall be new, of good quality, free from defects, and in conformance with the contract documents. Subcontractor warrants that all of its work shall be performed in a workmanlike manner, in conformance with the contract documents, with prevailing industry standards, and free from defects in workmanship and materials. Subcontractor shall, upon demand, promptly correct any of its work that is defective or not in compliance with the contract documents, at no additional cost to Contractor or Owner. Subcontractor shall bear all costs associated with correcting such defective work, including all costs of uncovering its work and of any additional inspections and testing, and Subcontractor shall indemnify Contractor and Owner for all costs and damages incurred by Contractor or Owner due to such defect. For a period of one (1) year following the date of acceptance of the Project by Owner, Subcontractor agrees to remedy all urgent warranty items that may affect the functionality of the project within 24 hours. Additionally, Subcontractor agrees to remedy all warranty items that do not fail within the urgent category within 3 working days and agrees to bear all costs associated with the correction of its defective work.

8. ASSIGNMENT OF SUBCONTRACT

Subcontractor shall <u>not</u> sublet or assign this subcontract nor sell or assign the proceeds of this subcontract; (1) All parties working under this subcontract are to be fully insured, per section 1, under Subcontractor's Insurance policies and must be a direct employee of Subcontractor. (2) Required permits for work must be pulled under Subcontractor's name, it is strictly prohibited to sublet a third party to pull permits for work being performed by Subcontractor. If it is discovered that the subcontractor has sublet or assigned this subcontract to another party Horizon Retail Construction, Inc. reserves the right to either; (i) terminate this subcontract and contract direct with the third party entirely or (ii) subcontract direct with the third party and back charge this subcontract the cost plus a 10% administrative fee.

9. SITE CLEAN-UP

Subcontractors are responsible for their own clean up. If Subcontractor fails to keep jobsite clean and Horizon Retail Construction, Inc. must perform clean up on the jobsite, a cost of \$150/hr., will be deducted from subcontract. Furthermore, if Horizon Retail Construction, Inc. must hire a subcontractor to complete the clean-up, the total cost plus an administrative fee of 10% will be deducted. In the event, the site does not permit a dumpster to be placed on site, subcontractor will be required to haul their own debris off site daily, otherwise deductions will be assessed.

10. NOTICE TO MAN THE JOB

Subcontractors that fail to adhere to the construction schedule will be electronically sent a "24 Hour Notice to Man the Job". IF YOU FAIL TO MAN THE JOB AFTER RECEIPT OF NOTICE, YOU WILL BE TERMINATED IMMEDIATELY. Additionally, Subcontractor will be liable for any costs incurred to complete the agreed upon work. No further payments will be made until project is completed. If the cost to finish the work is more than the balance due, the Subcontractor will be required to pay such balance to the Contractor within thirty (30) days of receipt of costs.

11. UNION SUBCONTRACTORS

Must be current on all dues to their respective union(s). Letters of compliance are required with contract execution and payment is contingent upon their receipt.

12. PAYMENT TERMS AND SUPPLIER LIEN WAIVERS:

Subcontractor will be held to the following additional requirements:

- (a) Before and as a condition of receiving the first draw, which can be no more than 50% of contract amount, the subcontractor is required to complete and execute the attached form "<u>List of all Suppliers on Project with Horizon Retail Construction</u>," listing all suppliers and equipment rental companies who have supplied material, labor or equipment on project.
- (b) Before and as a condition of receiving more than 50% of contract amount, the subcontractor will need to provide from all suppliers and equipment rental companies, an executed "Unconditional Final Waiver of Lien For: Material/Equipment/Services Suppliers"
- (c) At the discretion of Horizon Retail Construction, Inc. the subcontractor may be requested to update the "<u>List of all Suppliers on Project with Horizon Retail Construction"</u> before receiving either the second or final draw on this project.
- (d) Payment for all work completed under this Subcontract shall be paid as follows: 50%-40%-10%. At no point will payment be made beyond your % of completion, to be determined by the Project Manager.
- (e) Do not send Invoices, unless specifically asked for. Your Subcontract is your invoice and 23250122-06 is your invoice number
