## Building Plan Review Reviewed By: Michael Weisenborn Rejected

1. Lee's Summit Code of Ordinance, Section7-130.10 - Business License. It shall be unlawfull for any person to engage in the construction contracting business without first obtaining a business license as required under the applicable provisions of Chapter 28 of the Lee's Summit Code of Ordinances.

Action required - Provide the name of the licensed general contractor. A minimum of a Class B license is required. This needs to be provided for permit appravel.

2. No person, other than a licensed contractor or employees of a licensed contractor, shall engage in electrical, plumbing or mechanical business, construction, installation or maintenance unless duly licensed in accordance with this section. Expert from Sec. 7-130, Lees Summit Code of Ordinances.

Action required - Provide the names of the licensed mechanical and electrical contracts prior to permit approval.

Fire Plan Review Reviewed By: Jim Eden Rejected

1. 2006 IFC 901.2- Construction documents. The fire code official shall have the authority to require construction documents and calculations for all fire protection systems and to require permits be issued for the installation, rehabilitation or modification of any fire protection system. Construction documents for fire protection systems shall be submitted for review and approval prior to system installation.

Provide shop drawings for sprinkler and alarm system alterations.

- 3. 2006 IFC 1004.3- Posting of occupant load. Every room or space that is an assembly occupancy shall have the occupant load of the room or space posted in a conspicuous place, near the main exit or exit access doorway from the room or space. Posted signs shall be of an approved legible permanent design and shall be maintained by the owner or authorized agent.
- 4. Door hardware from the building and assembly areas shall be panic hardware. Confirmed at inspection.
- 5. Provide electrical drawings showing exit and emergency lighting.
- 6. 2006 IFC 906.2 General requirements. Portable fire extinguishers shall be selected, installed and maintained in accordance with this section and NFPA 10.

Show the locations of the fire extinguishers to be provided.

The review conducted by the City of Lee's Summit Codes Administration Department shall not be construed as a structural review of the project.
