#### Building Plan Review Reviewed By: Michael Weisenborn Rejected

1. Lee's Summit Code of Ordinance, Section7-130.10 - Business License. It shall be unlawfull for any person to engage in the construction contracting business without first obtaining a business license as required under the applicable provisions of Chapter 28 of the Lee's Summit Code of Ordinances.

Action required - Provide the name of the licensed general contractor for the project. A minimum of a Class B license is required.

2. No person, other than a licensed contractor or employees of a licensed contractor, shall engage in electrical, plumbing or mechanical business, construction, installation or maintenance unless duly licensed in accordance with this section. Expert from Sec. 7-130, Lees Summit Code of Ordinances.

Action required - Provide the names of the licensed mechanical, electrical and plumbing sub-contractors.

- 3. 2006 IBC 1006.3 Illumination emergency power. The power supply for means of egress illumination shall normally be provided by the premises electrical supply. In the event of power supply failure, an emergency electrical system shall automatically illuminate the following areas.
- 1. Aisles and unenclosed egress stairways in rooms and spaces that require two or more means of egress.
- 2. Corridors, exit enclosures and exit passageways in building required to have two or more exits.

- 3. Exterior egress components at other than the level of exit discharge until exit discharge is accomplished for buildings required to have two or more exits.
- 4. Interior exit discharge elements, as permitted in Section 1024.1, in buildings required to have two or more exits.
- 5. Exterior landings, as required by Section 1008.1.5, for exit discharge doorways in building required to have two or more exits.

The emergency power system shall provide power for a duration of not less than 90 minutes and shall consist of storage batteries, unit equipment or an on-site generator. The installation of the emergency power system shall be in accordance with Section 2702.

Action required - Item 5 requires emergency lighting on the exterior of the building at the egress points. If it is not already provided it needs to be added into this project. This comment is for information purposes and will be verified on inspection.

1. 2006 IFC 505.1- Address numbers. New and existing buildings shall have approved address numbers, building numbers or approved building identification placed in a position that is plainly legible and visible from the street or road fronting the property. These numbers shall contrast with their background. In Multi-tenant commercial building where tenants have multiple entrances located on different sides of the building, each door shall be addressed. Address numbers shall be Arabic numerals or alphabet letters. Numbers shall be a minimum of 4 inches (102 mm) high with a minimum stroke width of 0.5 inch (12.7 mm).

# ALL EXTERIOR DOORS TO THE SPACE SHALL HAVE PROPER ADDRESSING, VERIFIED AT INSPECTION

2. 2006 IFC 906.5- Conspicuous location. Portable fire extinguishers shall be located in conspicuous locations where they will be readily accessible and immediately available for use. These locations shall be along normal paths of travel, unless the fire code official determines that the hazard posed indicates the need for placement away from normal paths of travel.

#### PROVIDE A MINIMUM OF TWO 2A10B:C FIRE EXTINGUISHERS, VERIFIED AT INSPECTION

#### 3. 1008.1.8.4 Bolt locks.

Manually operated flush bolts or surface bolts are not permitted.

#### THUMB LATCH OR PANIC HARDWARE SHALL BE USED ON EXIT DOORS, VERIFIED AT INSPECTION

#### 4. 1006.3 Illumination emergency power.

The power supply for means of egress illumination shall normally be provided by the premises' electrical supply. In the event of power supply failure, an emergency electrical system shall automatically illuminate the following areas:

- 1. Aisles and unenclosed egress stairways in rooms and spaces that require two or more means of egress.
- 2. Corridors, exit enclosures and exit passageways in buildings required to have two or more exits.
- 3. Exterior egress components at other than the level of exit discharge until exit discharge is accomplished for buildings required to have two or more exits.
- 4. Interior exit discharge elements, as permitted in Section 1024.1, in buildings required to have two or more exits.
- 5. Exterior landings, as required by Section 1008.1.5, for exit discharge doorways in buildings required to have two or more exits.

#### PROVIDE EMERGENCY EXTERIOR EGRESS LIGHTING IF NOT ALREADY EXISTING

5. 907.12 Duct smoke detectors.

Duct smoke detectors shall be connected to the building's fire alarm control panel when a fire alarm system is provided. Activation of a duct smoke detector shall initiate a visible and audible supervisory signal at a constantly attended location. Duct smoke detectors shall not be used as a substitute for required open area detection.
