5. The plans do not provide for exhaust in the nail/pedicure area as required by the 2006 IMC.

Action required - Provide detailed information on the plans.

Mike Weisenborn 11/21/2013 2:47 PM - Installtion of exhaust fans at the ceiling does not meet the requirement for collection at the source of the odor. It has been our practice to require exhaust openings at the table top and within 12 inches of the floor at pedi stations. Typically this is a ducted system that runs to a single exhaust fan which runs continuously. Make needed corrections.

1. 2006 IFC 901.2- Construction documents. The fire code official shall have the authority to require construction documents and calculations for all fire protection systems and to require permits be issued for the installation, rehabilitation or modification of any fire protection system. Construction documents for fire protection systems shall be submitted for review and approval prior to system installation.

Provide sprinkler plans if alterations are required

2. 2006 IFC 907.1.1- Construction documents. Construction documents for fire alarm systems shall be submitted for review and approval prior to system installation. Construction documents shall include, but not be limited to, all of the following: 1. .A floor plan which indicates the use of all rooms. 2. Locations of alarm-initiating and notification appliances. 3. Alarm control and trouble signaling equipment. 4. Annunciation. 5. Power connection. 6. Battery calculations. 7. Conductor type

and sizes. 8. Voltage drop calculations. 9. Manufacturers, model numbers and listing information for equipment, devices and materials. 10. Details of ceiling height and construction. 11. The interface of fire safety control functions.
