1. 2011 NEC 501.1 Scope. Article 501 covers the requirements for electrical and electronic equipment and wiring for all voltages in Class I, Division 1 and 2 locations where fire or explosion hazards may exist due to flammable gases or vapors or flammable liquids.

Action Required: Compliance with Article 501 for the installation of all electrical wiring, conduit, devices, etc. in a Class I, Division I location will be verified during inspections. This comment is for informational purposes.

- 1. Emergency shut off shall be no closer than 20' and no further than 100'. Per phone conversation with Electrical Associates the shut off will be located on the fence and accessible from either side of the fence.
- 2. 2012 IFC 407.3- Identification. Individual containers of hazardous materials, cartons or packages shall be marked or labeled in accordance with applicable federal regulations. Buildings, rooms and spaces containing hazardous materials shall be identified by hazard warning signs in accordance with Section 2703.5.

- 3. Tank and appurtances shall conform to information originally submitted in the hazarsdous materials permit application
