A ninety (90) calendar day time period commences from the above date of issuance for completion and submittal to the City of all required final acceptance items as directed in Lee's Summit's Design and Construction Manual (Ordinance 5813). In the event all work is not complete and all items submitted within 90 days, no additional building permits will be issued and inspections on any building permits for any building within the property described on the Certificate of Substantial Completion may be suspended at the discretion of the City.

A Certificate of Final Acceptance for the project will be issued when all requirements are fully met. A Certificate of Final Acceptance must be obtained prior to issuance of permanent occupancy for any building within property described on the Certificate of Substantial Completion. Also, maintenance bond(s) submitted for this site do not go into effect until the date a Certificate of Final Acceptance is issued.
