I have circled around again with our Public Works Department and we are comfortable closing out the Parking Garage permits and not going to need any as-built drawings or sanitary sewer profile for the project.

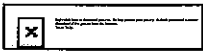
With these items being resolved – to my knowledge that completes all outstanding issues related with the development from a construction/building permitting perspective.

John – you may go ahead and issue the Certificate of Occupancy on any open related building permits on the parking garage.

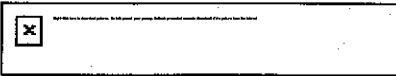
Kevin -- great job getting all the loose ends wrapped up with this development. You did a great job!
