Please accept this letter in support of our code modification request related to the following permit review comment:

6. 2012 IBC 1009.15 Handrails. Stairways shall have handrails on each side and shall comply with Section 1012. Where glass is used to provide the handrail, the handrail shall also comply with Section 2407. (see code for exceptions)

Action required: Modify drawings and details to show handrails on both sides of the stairs serving raised platform in sanctuary.

Although the code lists no specific exception with respect to platform stair handrails, it is common practice across the country to only provide handrails on one side of platform stairs.

We understand the intent of having handrails on both sides of a stair is to provide handrail graspability for two people on the stair at the same time, not for the ability for one person to grasp both handrails at the same time. The amount of traffic on the platform stairs will be very minimal. The frequencey of two people being on these stairs at the same time is negligible.

We submit that one handrail on each side more than accommodates the required egress width for the platform occupant load (see egress/handrail intent established in IBC Section 1012.9).

Additionally, we believe providing a handrail on both sides of the platform stairs creates an unnecessary and unsightly visual abstruction from the seating area to the platform. We respectfully request that a handrail be required on the wall side of each platform stair only.
