other fire protection systems and appurtenances thereto shall be subject to acceptance tests as contained in the installation standards and as approved by the fire code official. The fire code official shall be notified before any required acceptance testing. The fire code official shall be notified 48 hours before any required acceptance test.

2. WHEN WIRING THE NEW HOOD MAKE SURE TO INCLUDE THE HOOD LIGHTS ALONG WITH ALL ELECTRICAL UNDER THE HOOD AND NATURAL GAS SERVICE TO THE APLIANCES UNDER THE HOOD TO TERMINATE ON ANSUL ACTIVATION. (VERIFIED AT TESTING)
