The City shall send notification to the Developer and/or Contractors listing any defects discovered as a result of the inspection. The Developer and/or Contractor shall have the opportunity to immediately correct any defects at their expense, otherwise the City shall make a claim against the maintenance bond(s) prior to its/their expiration to finance correction of said defects.
