1. ACTION RWEQUIRED; (ACKNOWLEDGED)

Fire Plan Review

ALL DELAYED EGRESS DOORS, ELECTRIC STIKES, CARD READERS, SHALL UNLOCK UPON ACTUATION OF THE FIRE SPRINKLER SYSTEM, FIRE ALARM SYSTEM, POWER LOSS TO THE LOCK, A SIGNAL FROM THE COMMAND CENTER. INFORMATION PURPOSES, VERIFIED AT TESTING.

2. ACTION REQUIRED: (ACKNOWLEDGED)

2012 IFC 907.1.1- Construction documents. Construction documents for fire alarm systems shall be submitted for review and approval prior to system installation. Construction documents shall include, but not be limited to, all of the following: 1. .A floor plan which indicates the use of all rooms. 2. Locations of alarm-initiating and notification appliances. 3. Alarm control and trouble signaling equipment. 4. Annunciation. 5. Power connection. 6. Battery calculations. 7. Conductor type and sizes. 8. Voltage drop calculations. 9. Manufacturers, model numbers and listing information for equipment, devices and materials. 10. Details of ceiling height and construction. 11. The interface of fire safety control functions. PROVIDE AS BUILT PLANS FOR ANY ALTERATIONS TO THE ALARM SYSTEM. INFORMATION PURPOSES

3. ACTION REQUIRED: (ACKNOWLEDGED)

2012 IFC 505.1- Address numbers. New and existing buildings shall have approved address numbers, building numbers or approved building identification placed in a position that is plainly legible and visible from the street or road fronting the property. These numbers shall contrast with their background. In Multi-tenant commercial building where tenants have multiple entrances located on different sides of the building , each door shall be addressed. Address numbers shall be Arabic numerals or alphabet letters. Numbers shall be a minimum of 4 inches (102 mm) high with a minimum stroke width of 0.5 inch (12.7 mm).

PROVIDE SUITE ADRESSING OFF THE CORRIDOR FOR ALL DOORS LEADING INTO THE SUITE. VERIFIED AT INSPECTION.

4. ACTION REQUIRED: (ACKNOWLEDGED)

2012 IFC 901.2- Construction documents. The fire code official shall have the authority to require construction documents and calculations for all fire protection systems and to require permits be issued for the installation, rehabilitation or modification of any fire protection system. Construction documents for fire protection systems shall be submitted for review and approval prior to system installation.

PROVIDE AS BUILT PLANS FOR ANY ALTERATIONS TO THE FIRE SPRINKLER SYSTEM. INFOMATION PURPOSES.

5. ACTION REQUIRED: (ACKNOWLEDGED)

2012 IFC 901.5- Installation acceptance testing. Fire detection and alarm systems, fire-extinguishing systems, fire hydrant systems, fire standpipe systems, fire pump systems, private fire service mains and all other fire protection systems and appurtenances thereto shall be subject to acceptance tests as contained in the installation standards and as approved by the fire code official. The fire code official shall be notified before any required acceptance testing. The fire code official shall be notified before any required acceptance testing.

6. ACTION REQUIRED: (ACKNOWLEDGED)

ALL POWER OUTLETS, LIGHTS, SWITCHES POWERED BY THE GENERATOR NEED TO BE TESTED FOR CONNECTION TO THE GENERATOR PANEL PRIOR TO THE FINAL INSPECTION. DOCUMENTATION OF THE TEST PROVIDE TO THE FIRE DEPARTMENT AND CODES ADMINISTRATION.
