A comprehensive inspection was completed for this project. It has been determined by Development Services that a Certificate of Substantial Completion can be released. The following items were incomplete as of the date of this letter. The developer, contractors and engineers have ninety (90) days to complete these deficiencies in accordance with the City of Lee's Summit's, Design and Construction Manual, Ordinance 5813. Failure to complete all items may result in a freeze of building permits until all items are corrected and a Certificate of Final Acceptance is issued.

PUNCH LIST CORRECTIONS:

- 1) ANY SANITARY SEWER MANHOLES THAT ARE NOT ACCESSIBLE NEED TO BE UNCOVERED AND RAISED TO GRADE. MANHOLES: A-4, A-7 WERE NOT ABLE TO BE LOCATED. SEE ATTACHED MAP A.
- 2) ANY TRASH AND DEBRIS NEEDS TO BE PICKED UP AROUND THE SITE.
- 3) ANY CONSTRUCTION MATERIALS THAT NOT BEING USED FOR THE CURRENT PHASE NEED TO BE REMOVED OFFSITE (E.G. BARREL SECTIONS, CORRUGATED PIPE, ETC).
- 4) THE DRAINAGE DITCH ON THE NORTH SIDE OF SW NAPA VALLEY DR. NEEDS TO BE CLEANED UP AND A NEW FLARED END SECTION PROPERLY INSTALLED; AN ADEQUATE AMOUNT OF RIP RAP IN PLACE AND PERMANENT TRM INSTALLED TO PREVENT SOIL EROSION. SEE ATTACHED MAP B (FES N-1).

- 5) THE SWALE THAT RUNS BETWEEN THE 1ST & 3RD PLAT(S) FROM SW STONEY BROOK DR. TO SW NAPA VALLEY DR. NEEDS TO BE GRADED AND HAVE TRM (TURF REINFORCEMENT MAT) INSTALLED TO ESTABLISH VEGEATATION IN THE SWALE. SEE ATTACHED MAP B (SWALE).
- 6) ANY LIFT RINGS THAT ARE ON STORM BOXES NEED TO BE CUT OFF.
