Mr. Robbins,

Emery Sapp and Sons Inc. and Streetwise our pavement marking Subcontractor have agreed to touch up the faded painted pavement markings on the Ward Road Improvements project. Based on our onsite meeting last week we have agreed that the faded markings are predominately located at the Donovan Road and Tudor Road intersections where the higher volume of traffic has been driving on the markings. The intention is for Streetwise to paint the faded areas when their paint truck is in this area of Lee Summit. The pavement markings that have faded under the Ward Road Project will be touched up this 2018 season. I am also in agreement that we should leave the silt fence in place along Ward where the future Summit Square PH 2 Apartments are slated to go. The phase 2 Apartments are scheduled to start mid-summer 2018 and will utilize the fence that is currently in good usable condition.
