1. Riser diagram / NFPA symbols

ACTION REQUIRED: Alarm system riser diagram and the NFPA symbol legends need to include the WP horn/strobe, the W-horn/strobe, regular addressable smoke detector and NAC symbols

2. NAC panel

ACTION REQUIRED: Plans show NAC circuits but no NAC panel .

Plans need to show the NAC panel locations.

3. Manual pull stations

ACTION REQUIRED: Eliminate all but one manual pull station from all buildings including the clubhouse. The one manual pull station is to be mounted by the FAC locations.

4. Battery Caclulations

ACTION REQUIRED: Battery Calculations need to include the size and number of batteries to be installed in each buildings FAC and NAC panels.

5. FAA location

ACTION REQUIRED: Relocate the FAA in the clubhouse from the corridor to the front entry vestibule.

6. Strobe notification devices

ACTION REQUIRED: Replace the horn and horn/strobe notification devices with STROBE only notification in the following areas.

CLUBHOUSE: restrooms, dogwash room, massage room and breakroom

7. Smoke detection

ACTION REQUIRED: Plans need to show addressable smoke detection in the following areas.

Sheet FA1-16 Type V bldg. 2nd floor hallways - no garages, all levels need addressable smoke detection in hallways Sheet FA1-18 Type VI bldg. 2nd floor hallways - no garages, all levels need addressable smoke detection in hallways Elevator lobbys and hoistways/pits

ACTION REQUIRED: Provide manufactures specs for the following

- strobe only notification devices for the clubhouse restrooms and other clubhouse rooms as specified.
- addressable smoke detection devices.
- Fire Annunciators (needs the ability to reset the main fire panel)

NOTES

- (1) Each building shall have an addressable fire Alarm Control Panel installed, if an addressable anunciator pad does not have the ability to reset each individual building and the main clubhouse fire alarm panel from the anunciators location.
- (2) All buildings that do not have garages and that do not have natural gas fed appliances that generate CO still require addressable smoke detection on all levels in the hallways not combination devices. Plans and legends should indicate the difference between addressable smoke detection and the addressable combination detection.
- (3) If addressable anunciators are installed in each apartment building instead of addressable Fire alarm control panels the addressable anunciators will be installed in the same room as the NAC panels.
- (4) Fire Alarm communicators can be Cellular instead of pots land lines if they meet requirements. REQUIREMENTS:
 - (a.) must meet UL 864 requirements for sole, primary or backup path communications
 - (b.) Compliant with the 2013 Edition of NFPA 72,

The applicant understands that the requirements listed above must be corrected to conform to applicable City Codes and Ordinances.
