- 1. Sidewalks with dimensions must be provided on the plot plan.
- ***Missing ada ramp and sidewalk call out*
- 2. Drainage swales (where required); show spot elevations within the swale as required to conform to the approved master drainage plan (if applicable), must be provide
- *There is a swale that begins in the rear yard*
- 3. Show all manholes, water valve boxes, fire hydrants, and stormwater structures.
- *Missing curb inlet*
- 4. A as-graded plot plan per Section 7-160, Code of Ordinances, is required prior to occupancy.
- *Please add note "AS-GRADED PLOT PLAN IS REQUIRED PRIOR TO SODDING."*

Residential Plan Review Reviewed By: Dylan Eppert Rejected

- 1. Provide square footage of living area, garage area, unfinished basement area, etc (IRC Section R304) Provide sq footage for garage, unfinished basement, covered deck, uncovered deck on construction plans.
- 2. Designate use of each room or space including but not limited to; basement storage, garages, and attic areas intended for storage space. Need to clarify if you plan on having a covered deck as well as an uncovered deck. Plans shows both but application shows only a covered deck.
- 3. Detail required separation between garage and living area including door, door closer and gypsum board. (IRC R302.5) We need door closer detain.
- 4. Please provide the address on all pages of the construction documents.
- 5. Mechanical contractor must be licensed with the city of Lee's Summit.

The review conducted by the City of Lee's Summit Development Services Department shall not be construed as a structural review of the project.
