1. Lee's Summit Code of Ordinance, Section7-130.4 - Business License. (excerpt)

No person, other than a licensed contractor or employees of a licensed contractor, shall engage in electrical, plumbing or mechanical business, construction, installation or maintenance unless duly licensed in accordance with this section.

Action required: MEP subcontractors are required to be listed on permit. Provide company name of licensed mechanical contractor. Dowell Construction does not have a LS business license.

Building Plan Review Reviewed By: Joe Frogge Rejected

1. Inadequate information to complete review.

Provide the following:

- Complete electrical design including materials and methods to comply with 2017 NEC Article 500 for Class 1, Division 1 locations.
- Locate equipment on floor plan
- Locate exhaust distribution ductwork and terminations.
- Demonstrate compliance with 2018 IMC 502.7 & 510.2.

- Provide make-up air design if provided.
- Provide contact information for engineer of record. (Mr. Hirst did not seal drawings)

3. (Action Required)

The booth will need an approved automatic fire-extinguishing system. 2018 IFC 2404.4 Provide plans showing protection

2. 2018 IFC 906.2- General requirements. Portable fire extinguishers shall be selected, installed and maintained in accordance with this section and NFPA 10.

(Action Required)

Provide a 40B extinguisher within 30 feet of the booth.

1. 2018 IFC 901.5- Installation acceptance testing. Fire detection and alarm systems, fire-extinguishing systems, fire hydrant systems, fire standpipe systems, fire pump systems, private fire service mains and all other fire protection systems and appurtenances thereto shall be subject to acceptance tests as contained in the installation standards and as approved by the fire code official. The fire code official shall be notified before any required acceptance testing. The fire code official shall be notified 48 hours before any required acceptance test.
