Specifically, the builder has requested to pour a thicker suspended slab (8" to 12") than originally noted on the plans, using a 3" instead of a 2" corrugated metal deck. This occurs at both the Front and Side garages.

Our firm has determined there are no additional changes required to the structure for the aforementioned request.

The above recommendation is based on no other changes to the structure from the originally sealed drawings. Our firm has made no attempt to verify existing conditions.






Figure 1 – Revised Suspended Slab Notes (Front Garage)




Figure 2 – Revised Suspended Slab Notes (Side Garage)
