The rear property line should be 112.15 instead of 112.16 per the recorded plat

- 2. Plot Plan is not scaling out on the 1"=30' scale. It is scaling out on a 1"=20' scale.
- 3. A as-graded plot plan per Section 7-160, Code of Ordinances, is required prior to occupancy.
- 4. Show all manholes, water valve boxes, fire hydrants, and stormwater structures.

Please show manhole located on the corner of the lot

5. Please provide the bottom elavations for the retaining walls
