NOTIFICATION OF BLASTING OPERATIONS

Missouri State Statute 319.339 requires any person using explosives within Missouri to notify the Division of Fire Safety at least two business days in advance of first using explosives at a site where blasting has not been previously conducted. If blasting will be conducted at an ongoing project, such as a long-term construction project, or at a permanent site, such as a mine, the person shall only be required to make one notice to the division of fire safety in advance of the first use of explosives. This section shall not apply to any blasting required by a contract with any agency of the state of Missouri, any federal agency, or any political subdivision.
