







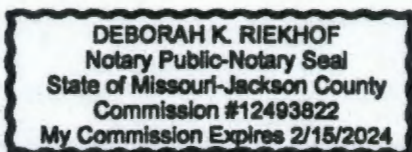

## Exterior Renovation Permit

New glazing will be 1" clear insulated glazing units. Existing frameless glass entry doors and solid side entry door, will be replaced with bronze anodized aluminum frame doors with clear glass."
