1. The project cost, which is used to establish the permit fee, has not been provided.

2. Inadequate information to complete review.

Provide the following:

- Label use of all areas including rear spaces and open spaces.
- Specify all details of wall construction
- Show locations of any new plumbing fixtures (shampoo bowls?)

3. 2018 IBC 2902.3 Employee and public toilet facilities. For structures and tenant spaces intended for public utilization, customers, patrons and visitors shall be provided with public toilet facilities. Employees associated with structures and tenant spaces shall be provided with toilet facilities. The number of plumbing fixtures located within the required toilet facilities shall be provided in accordance with Section 2902 for all users. Employee toilet facilities shall be either separate or combined employee and public toilet facilities.

4. 2018 IPC 403.1 Minimum number of fixtures. Plumbing fixtures shall be provided in the minimum number shown in Table 403.1, based on the actual use of the building or space. Uses not shown in Table 403.1 shall be considered individually by the code official. The number of occupants shall be determined by the International Building Code.

Action required: Provide drinking fountains or approved alternate. (water bottles? Access to break room sink? Water cooler?)
