## **PUNCH LIST CORRECTIONS:**

1. Establish vegetation of 70% or more throughout entire site that was disturbed.

2. Issue a Final Affidavit and Agreement.

3. Maintenance Bond for 3 yrs. for 50% if the total cost of construction for all public infrastructure. Street and paving total cost-\$1,03,452.92-Storm Sewer total cost-\$602,192.98-Sanitary Sewer total cost-\$687,565.60-Water total cost- \$491,355.04-Total Cost -\$2,794,536.54-50% = \$1,397,268.27

4. Replace broken curbing and sidewalk panels- marked with a pink X

5. Install missing sidewalk panels.

6.Remove construction debris and trees that are down.

7. Maintain erosion control until vegetation has been established.

8. Remove erosion control devices when vegetation has been established.

9. Design related issues-

- -Detention basin bottom slope -minimum 2% issue
- -Updated storm study to reflect the changes to the emergency spillway
- -It doesn't appear that any of the contours around the detention basins are "as graded" contours

-The berm and swale at the discharge from ES 10-0 (storm line 10) into the detention Tract E needs "as -graded" contours

-As-built/as-graded record drawing for the spillway reconstruction plans

-Record drawing for the Obrien/Pryor Road intersection improvements.
