THE KEY BOX SHALL BE OF AN APPROVED TYPE AND SHALL CONTAIN KEYS TO GAIN NECESSARY ACCESS AS REQUIRED BY THE FIRE CODE OFFICIAL. ORDER A KNOXBOX FROM KNOXBOX.COM. PLACEMENT TO BE MADE BY THE FDC."
- b) Added Knoxbox location to plan at entry ways.
