- 2. Existing and finished elevations at building footprint corners must be provided on the plot plan. no address found. no finish elevations
- 3. The top of foundation elevation must be provided on the plot plan.
- 4. The garage floor elevation must be provided on the plot plan.
- 5. The Basement floor elevation and basement type (e.g. full/standard, daylight, walk-out, etc.)
- 6. Contours, spot elevations and drainage flow arrows (as required) shall be provided on the lot.
- 7. Spot elevations and/or drainage flow arrows shall be provided throughout the lot.
- 8. Minimum Building Opening Elevation (MBOE) and location on structure must be provided on the plot plan.

9. Basement egress location(s) and elevation of the lowest adjacent grade must be provided on the plot plan.
