set and aggregate compacted. It is compliant at this time. 3-5-21 9:42am They are pouring the sidewalk on the north west corner. They have been informed to stay ADA compliant.

3-6-21 7:27am The Forman for Bottorff informed me Friday the 5th that they would need a inspection Saturday the 6th. The forms are set on the south east corner of the building. The aggregate is in and compacted. They have steel in place with grade pins. Geiger is supplying approximately 15 yards of concrete for the pour. They have pulled the sidewalk forms on the north west corner and will be making saw cuts.
