Plot Plan Review Reviewed By: Brandon Kalwei Rejected

- 1. The rear yard demision(s) must be provided on the plot plan.
- 2. Deck location, with dimensions to property lines must be provided on the plot plan. in R-1 zoning, the primary structure cannot be within 30' of the property line. The covered deck is currently at 23.2'
- 3. Sidewalks with dimensions must be provided on the plot plan.
- 4. Drainage swales/berms: provide cross-section elevations as required to conform to the accepted "As graded" Master Drainge Plan (MDP), include cross-section detail from MDP. no swale shown on plot plan, swale shown on MDP. needs to be on the plot plan.
- 5. Drainage swales (where required); show spot elevations within the swale as required to conform to the approved master drainage plan (if applicable), must be provide no swale shown on plot plan, swale shown on MDP. needs to be on the plot plan.
- 6. Minimum Building Opening Elevation (MBOE) and location on structure must be provided on the plot plan.
- 7. A as-graded plot plan per Section 7-160, Code of Ordinances, is required prior to occupancy.

# Residential Plan Review Reviewed By: Brandon Kalwei Rejected

- 1. One (1) complete permit application. Application does not show unfinished basement sq. ft. and suspended slab. plans show both unfinished basement and suspended slab. need to correct application
- 2. Footings, column pads, piers and grade beams dimensions. (IRC Section R403) do not see details for column pads
- 3. Footings, column pads, piers and grade beams reinforcement size and spacing. do not see details for column pads
- 4. need to confirm plumbing contractor's business name
