Plot Plan Review Reviewed By: Brandon Kalwei Rejected

- 1. Deck location, with dimensions to property lines must be provided on the plot plan. plot plan shows covered patio, needs to be covered deck
- 2. All easements with dimensions must be provided on the plot plan. no 7.5' easement shown on MDP on west side
- 3. Minimum Building Opening Elevation (MBOE) and location on structure must be provided on the plot plan.
- 4. A as-graded plot plan per Section 7-160, Code of Ordinances, is required prior to occupancy.

Residential Plan Review Reviewed By: Brandon Kalwei Rejected

- 1. Provide square footage of living area, garage area, unfinished basement area, etc (IRC Section R304) cannot locate unfinished basement sq. ft.
- 2. Identify emergency escape openings from bedrooms and basement(s). (IRC Section R310 as amended per Ordinance) egress windows need to be labeled in basement

- 3. Designate locations of smoke detectors and carbon monoxide detectors. (IRC Section R314 and R315) smoke/CO detector needs to be labeled outside of bedrooms
- 4. Provide combustion air calculations and specify transfer air grilles for fuel burning appliances located in confined space(s). (IRC Chapter 17 and Section G2407)
- 5. house plans and plot plan layout need to match, currenlty flipped

The review conducted by the City of Lee's Summit Development Services Department shall not be construed as a structural review of the project.
