7/29/21 Thursday (Clarkson Gregg Crew)

Contractor installed 22.5 degree bend at Sta. 1+60, 1-6" LS FH at Sta. 2+00, 45 degree bend at Sta. 3+03.30 on private Line C. The Line is 8" DIP locking

restraint gasket water pipe. Contractor continues to work on installation of private line 12:00PM.

8/2/21 Monday (Clarkson Gregg Crew)

Contractor continued installation of water line on River Road just before Sta. 5+00 (FH). Contractor had installed to approximately Sta. 8+50 @ 2:30PM. Two 45 degree bends were eliminated from around CIs at Sta 3+96 to 4+20 & Sta 5+20 to 5+44 on private line C. FH was installed at Sta. 7+00 and 45 bends were eliminated at Sta. 8+01 to 8+28 around CI, Fogel-Anderson was informed about need changes due to improperly staking that crossed other utilities. Deflection of water line in able early allowed for required clearance. Contractor plans to have concrete come at 3:00PM for tees and bends on water main. Water installation was stopped around Sta. 9+30.

8/3/21 Tuesday (Clarkson Gregg Crew)

Contractor continued to install water main 8" from Sta. 9+30 to around 12+70. The contractor stop just short of crossing the street of River Road as-per plan. Contractor pour backing blocks behind tees and bends that were installed today.

Private Line C passed pressure test @160 psi from Backflow Preventer to the end of the line .

Contractor found and replace defective slip joint on piping with 2/8" sleeve and 3' Pup all fittings were mega lugged. The proximitie of the Sta. 5+05 adjacent to Fire Hydrant.

8/16/21 Monday

Contractor chlorinated Private Line C around 8:30AM.

10/29/21 Friday

Contractor with Lee's Summit Water Dept. was able to locate water main across I- 470.
