1. Deck location, with dimensions to property lines must be provided on the plot plan. needs to be labeled as covered deck

Residential Plan Review Reviewed By: Brandon Kalwei Rejected

- 1. Two (2) copies of construction drawings. (Plans to be signed and sealed by an architect or engineer registered in the State of Missouri.) building plans have wrong address
- 2. Provide square footage of living area, garage area, unfinished basement area, etc (IRC Section R304) cannot locate unfinished and finished basement sq. ft. and does not show unfinished basement on application
- 3. Designate use of each room or space including but not limited to; basement storage, garages, and attic areas intended for storage space. basement shows future basement finish, are you finishing it?
- 4. Identify emergency escape openings from bedrooms and basement(s). (IRC Section R310 as amended per Ordinance) egress needs to be labeled in bedroom if basement is finished
- 5. Designate locations of smoke detectors and carbon monoxide detectors. (IRC Section R314 and R315) smoke/CO detector needs to be outside of bedroom

- 6. Identify location(s) of vertical supports and purlins. (IRC Section R802.4.5)
- 7. Building plans show walkout basement, plot plan shows daylight, MDP shows standard. everything needs to match
