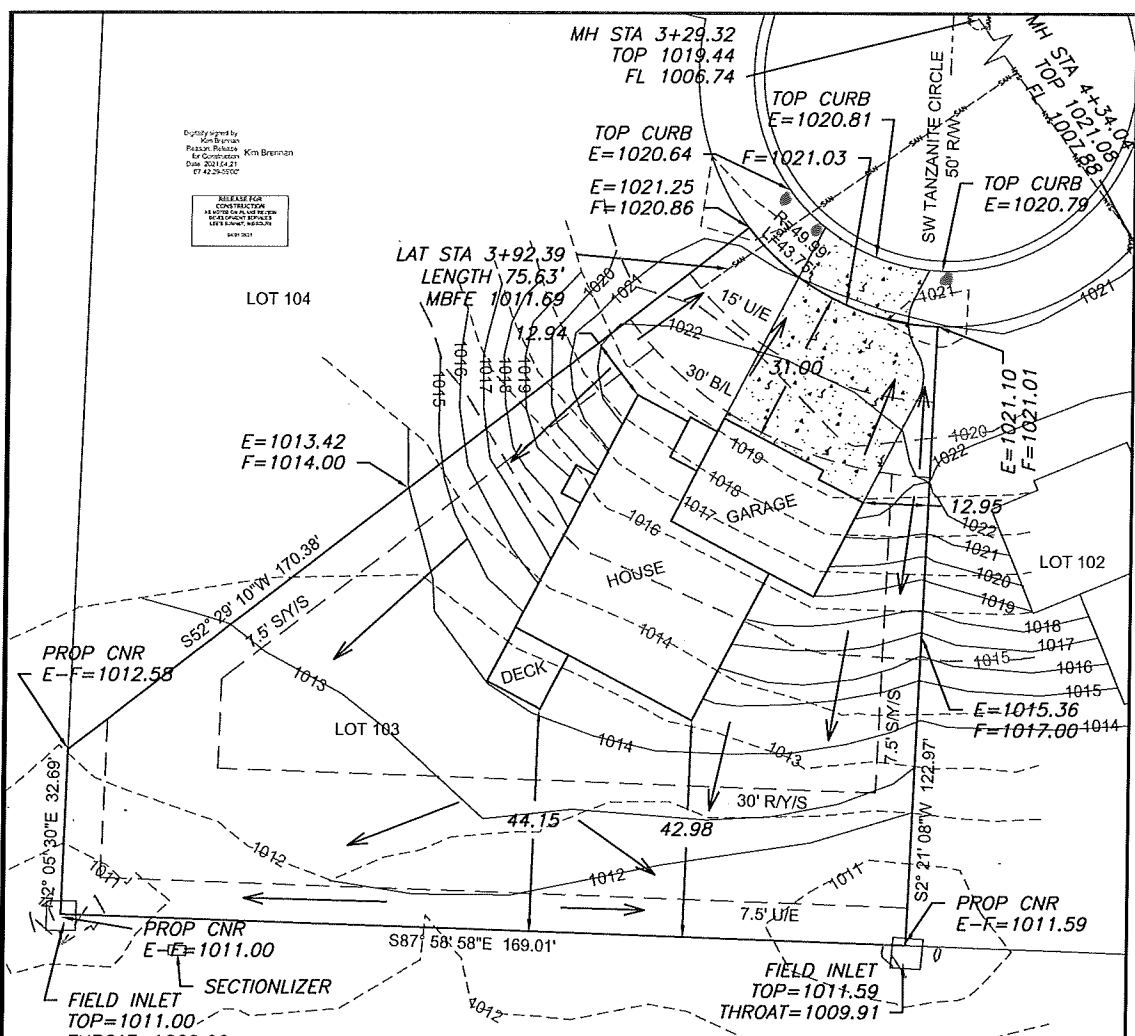

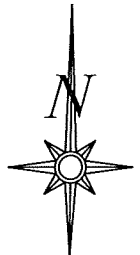

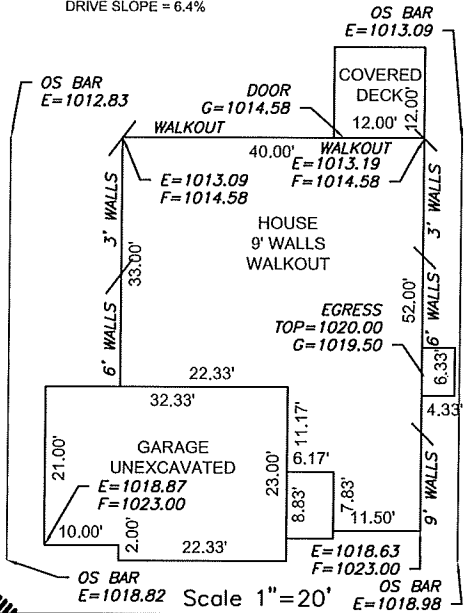

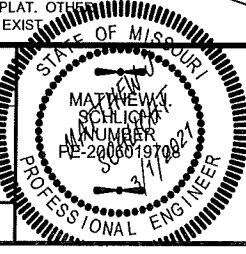
PLOT PLAN - LOT 103
