Not provided in the rear coner

2. Contours, spot elevations and drainage flow arrows (as required) shall be provided on the lot.

Please provide more contour lines in the rear of the lot to adhere to proper grading practices. Please also add drainage flow arrows in the front of the lot and add high point elevations where the water changes direction.

3. Minimum Building Opening Elevation (MBOE) and location on structure must be provided on the plot plan.

No MBOE's ae listed for the front of the lot on the MDP and in the rear they are listed as MBOE's and not MLO's.
