PERMIT REQUIREMENTS	<ul style="list-style-type: none"> The demolition of structures or buildings, partial or complete, shall require a demolition permit. The removal of one-story detached accessory structures used as tool and storage sheds, playhouses, and similar uses, provided the floor area does not exceed one hundred twenty (120) square feet does not require a demolition permit.
	<ul style="list-style-type: none"> When requested by the Building Official, the applicant shall provide; a structural engineers report that describes the methods of demolition including all necessary shoring; plans and information necessary to determine no hazards will be created that endanger the occupants, adjoining properties or general public.
	<ul style="list-style-type: none"> Gas and electric services must be properly abandoned and approved by the appropriate utility company prior to issuance of a permit for complete removal of a structure. Appropriate documentation from the electrical and gas companies documenting proper abandonment.
	<ul style="list-style-type: none"> Water and sanitary services must be abandoned by the Water Utilities Department prior to issuance of a permit for complete removal of a structure. Contact Water Utilities at 816-969-1900 for additional information.
	<ul style="list-style-type: none"> A right-of-way permit and possibly a traffic control permit are required for work located in the row-of-way. Contact the Public Works Department at 816-969-1800 for more information and permit requirements and issuance.
INSPECTIONS	<ul style="list-style-type: none"> Applicant shall furnish a certificate of liability insurance for personal and property damage in a minimum amount of one hundred thousand dollars (\$100,000) injury each person, three hundred thousand dollars (\$300,000) each occurrence, and fifty thousand dollars (\$50,000) property damage.
	<ul style="list-style-type: none"> Private disposal systems - The removal of private sanitary waste systems is regulated by the Department of Public Works, Jackson County Planning and Environmental Health. Please contact them at 816-881-4515 for further information.
	<ul style="list-style-type: none"> Contact the City of Lee's Summit Fire Department, 816-969-1300, PRIOR to removal of any underground fuel storage tank.
	<ul style="list-style-type: none"> Demolition waste and the abatement of hazardous materials is regulated by the Missouri Department of Natural Resources. For information regarding demolition waste regulations contact the Hazardous Waste Program at 573-751-3176. For information regarding asbestos contact Air Pollution Control at 573-751-4817. 	<ul style="list-style-type: none"> Burning of demolition waste of any kind is not allowed in the City of Lee's Summit. The applicant shall remove all rubbish and materials and fill excavations to existing grade so that the premises are left in a safe and sanitary condition and can be maintained in accordance with the Property Maintenance Code within twenty- A final inspection shall be scheduled after all work required by the demolition permit has been completed Permits issued for demolition work shall be valid for a maximum duration of sixty (60) days.
