Correction -Protect nm at garage corner less than 1.25" to face of stud

-Support hip and ridge at 2 car bay

-Address rafters not connected to ceiling joists at garage

-Fireblock tops dead spaces at garage/stairwell and use approved materials at

ceiling line

-Address double 2x10 at single car bay/double bay walkway taper cut greater

than 1/4th depth

-Fireblock ceiling line at single car bay window

-Provide anchor bolt at end of plate in single car bay back wall

-Anchor bolts to be in middle third of plate in single car bay

-Address walls not connected at top plate at kitchen/single car garage

-Provide lateral restraint for all ceiling joists above walls

-Land electrical at powder room ceiling

-Provide proper slope at dwv in attic space

-Support hip rafters at top in great room

-Seal top plate penetration at breakfast

- -Solid block and nail horizontal seams at exterior sheathing throughout
- -Protect electrical and seal bottom plate penetrations at master closet
- -Address over notched ceiling joists at master closet front corners
- -Address valley rafter not bearing 75%
- -Support hip and ridge at master closet
- -Use approved materials for ceiling line fireblocking throughout
- -Seal plate and floor penetrations in master shower/tub
- -Fireblock ceiling line at master shower/tub
- -Protect nm in master vanity less than 1.25" to face of stud
- -Address double LVLs taper cut greater than 1/4 and master bed
- -Address rafters over notched at master bed window
- -Identify ufer at both points of termination
- -Secure att 2" and smaller dwv at midpoint
- -Use specified hangers at I joist to LVL at mechanical room
- -Protect nm at top plate in bed 2 bath
- -Address over notched studs at exterior basement wall bed 2
- -Complete fur downs at hvac bed 2
- -Fireblock ceiling line basement bath/stairs
- -Fireblock dead space at basement powder room
- -Complete doorway to closed off powder room
- -Address floor joists with no bearing wall support south stair wall
- -Nail exterior sheathing
- -Provide CS-PF wall bracing per plan breakfast nook & great room ( 11 1/4 header per plan )
- -Install missing doors
- -Provide electrical nail guard behind master bed door & master vanity
- -Expose covered deck & porch for inspection
- -Anchor bolts shall be in middle 1/3 the width plate
- -Provide 4" bath exhaust per code
- -Replaced damaged bath exhaust flex in Bed 2 bath basement
- -Provide clearance can light to DWV basement bath 2
- -Provide anchor bolt within 12" of plate break

- -Provide soffit HVAC duct work bed 2
- -Address notched LVL header basement sliding glass door
