3. A code analysis shall be provided which includes but is not limited to occupancy type, occupant load, construction type, actual area, height and floors, allowable area, height and floors, and the codes to which the project is designed.

Action required: Include 2nd floor in code analysis.

Fire Plan Review Reviewed By: Jim Eden Approved with Conditions

1. 2018 IFC 1004.3- Posting of occupant load. Every room or space that is an assembly occupancy shall have the occupant load of the room or space posted in a conspicuous place, near the main exit or exit access doorway from the room or space. Posted signs shall be of an approved legible permanent design and shall be maintained by the owner or authorized agent.

Action required- Repost the adjusted occupant load for the first floor. Verified at inspection.

2. If the addition of the bar causes a need to adjust sprinkler head coverage or relocate alarm notification appliances. Have the appropriate fire protection contractor make adjustments and provide "as builts". All other conditions will be verified at inspection, including documentation of current inspections of the alarm and sprinkler systems.

The review conducted by the City of Lee's Summit Development Services Department shall not be construed as a structural review of the project.
