This letter is being sent in response to the plan review dated 22 February 2022. Reviewers comments may be paraphrased for brevity, and only comments requiring a response is shown.

1. **COMMENT:** Provide plans that are stamped by a Missouri licensed PE.
Include equipment data sheets with submission.

RESPONSE: Plan shall be furnished to a Missouri PE for review/stamping.
Also; system data sheets were provided to the installation contractor/
applicant, and shall be reminded to submit them.
2. **COMMENT:** Heat detection is not required for this Use Group.

RESPONSE: The heat detection shown is elective coverage as allowed, and is
desired by the Owners/Operators of these facilities, of which this
is one of dozens that are being opened across the country under this
general design. Elective coverage shall remain.
3. **COMMENT:** Remove all exterior notification appliances with the exception of the
one required for exterior sprinkler system notification located over
the FDC.

RESPONSE: External notification for employees within exterior fenced-in yards
shall be removed. Only sprinkler notification device remains.
4. **COMMENT:** Provide audible notification appliances in boarding and daycare
areas. Remove audible devices and replace with strobe-only devices
within the surgical rooms.

RESPONSE: It is disappointing that Private Mode Signaling is not accepted at
this facility as all others, however, these changes shall be made
within the boarding/day care areas. The surgical areas were supposed
to be strobe-only, and this plan error is now corrected.

5. **COMMENT:** Ceiling fans depicted for shutdown do not appear to be HVLS fans, and therefore do not require shutdown.

RESPONSE: The plans now reflect the removal of any ceiling fan shutdowns.
