3. Sidewalks with dimensions must be provided on the plot plan. label ADA ramp

1. Designate use of each room or space including but not limited to; basement storage, garages, and attic areas intended for storage space. basement labeled as optional, no walls around HVAC, etc. Need to show as finished basemnt and show unfinished area as well.

2. Designate locations of smoke detectors and carbon monoxide detectors. (IRC Section R314 and R315) need a smoke/CO detector outside of basement bedroom if finished

3. Provide combustion air calculations and specify transfer air grilles for fuel burning appliances located in confined space(s). (IRC Chapter 17 and Section G2407) need details if basement is finished
