- 2. A as-graded plot plan per Section 7-160, Code of Ordinances, is required prior to occupancy.
- 3. RETAINING WALL PLANS MUST BE SUBMITTED AND APPROVED WHEN READY TO BUILD.

1. Two (2) copies of construction drawings. (Plans to be signed and sealed by an architect or engineer registered in the State of Missouri.)

- 2. Provide square footage of living area, garage area, unfinished basement area, etc (IRC Section R304)
- 3. Identify type of roof/truss package (if used) complete with layout, component design, fastening details, blocking and sheathing requirements. (IRC Section 802.10)

4. Identify type of joist package or floor truss package (if used) complete with layouts, fastening details, blocking and bracing requirements and minimum sheathing.

5. Identify emergency escape openings from bedrooms and basement(s). (IRC Section R310 as amended per Ordinance)
