Please see below for our narrative regarding changes to the above-mentioned project, as well as the attached support documents described below.

# **ARCHITECTURAL CHANGES**

Here is a concept image of the previously submitted design from August 2021:



And here is the revised concept image of the Permit Resubmittal dated 04-29. These changes described below have affected all sheets within the Architectural set by Finkle + Williams Architecture:



- 1. Removed steel & wood composite canopy along west and south.
- 2. Removed wood composite vertical siding on west, south, and east.
- 3. Shifted the exterior wall at grids E/5 and revised massing at cultured stone (ST-1 per sheet A4.01)
- 4. Revised MP-1 to be Standing Seam Metal Panel instead of ACM per Exterior Material Legend on Sheet A4.01.
- Revised Trash enclosure to have overhead coiling doors with gray metal finish to coordinate with MP-1 instead of the wood-composite-clad steel swing-gates.

- S0.0 Updated epoxy type due to availability
- S1.1 Foundation changes at main entrance and trash room. Removed canopy columns.
- S2.1 Framing changes at main entrance and trash room. Removed canopy framing.
- S3.2 Updated foundation details for changes listed above.
- S4.3 Updated framing details for changes listed above.

## **ELECTRICAL CHANGES**

- E1.01 Revised lighting layout and switch location in trash enclosure. Added exterior sconce next to trash enclosure man door.
- E2.01 Added power for motorized garage doors for trash enclosure. Added keyed notes #9 and #10. Revised receptacle locations on interior/exterior wall at NW portion of Open Office 100.
- E3.01 Added power for EF-2.
- E4.01 Revised panelboard A for addition of circuit to EF-2. Revised panelboard B for addition of circuits to garage doors.

# MECHANICAL CHANGES

M1.01 Revised ductwork and CRU-2 location with wall revisions.

# PLUMBING CHANGES

- P1.01 Added roof drain and overflow roof drain to above trash enclosure.
- P2.01 Added roof drain piping for storm and overflow in trash enclosure.
  Added new overflow downspout to NE of trash enclosure.
  Revised condensate drain routing from CRU-2 and nearest floor drain location.
- P3.01 Revised location of exterior hose bib to outside of trash enclosure.

#### FIRE ALARM CHANGES

FA1.01 Added fire alarm device in trash enclosure.
