Mike, attached are PDFs of the building elevations with the sight lines shown from property line/edge of road, relative the finish floor elevation of the building. These are taken from each corner of the building, going to the north, south, east and west. We have used the same rooftop unit information that was previously provided; units that are 80" tall including the curb. The units are all shown 1 column line in from the edge of the building so that the units are not close to the edge where they would be visible. As you can see, based on the overall height of the building and the grade change around the building, these units should be screened from view.

The City's Unified Development Ordinance (UDO) explicitly calls for the full screening of RTUs on new construction buildings with parapet walls of at least equal height. Alternative screening methods can be approved by City Council via the 3-month public hearing process for a preliminary development plan. The ordinance doesn't grant staff the authority to grant alternative screening methods.

Attached is the proposed layout for the units. They will be approximately 60' from the edge of the building. The units, sitting on curbs, will be 80" tall. As you can imagine making the parapet all the way around the building 80" tall would be cost prohibitive, not only because of the additional height added to the building, but also because with a parapet that tall, we also need to engineer the roof joists to handle the weight of snow drifting up against these parapets. That requires larger bar joists for all areas adjacent to the building.

Based on how far off the building edge these units sit and how tall the building is, we are hopeful that there is a more reasonable approach possible to minimize their visibility.

Shawn,

Roof mounted equipment needs to be screened on all sides by the building's parapet walls per: Unified Development Ordinance Article 8, Section 8.180.E

Roof mounted equipment – All roof-mounted equipment shall be screened entirely from view by using parapet walls at the same height as the mechanical units. For additions to existing buildings that do not meet this standard, individual screens will be permitted, with the design subject to approval by the Director.
