Failure to complete all items will result in a freeze of building permits until all items are corrected and a Certificate of Final Acceptance is issued.

#### **PUNCH LIST CORRECTIONS:**

1. Provide a 3 year maintenance bond for 50% Of the total cost of construction for all public infrastructure. Water- \$36,908.00 Sanitary- \$155,132.00 Street and Storm-street \$185,567.41 curb and ADA-\$93,245.00 strorm-\$271,793,39 signs-\$4,250.00 =\$746,085.80/2= **\$373,042.90** 

- 2. Provide a Final Affidavit and Agreement
- 3.Establish 70% vegetation throughout entire plat.
- 4. Make repairs to all curbs that were damaged/ grout the cracks.
- 5. Make repairs to detention/retention basin structure.
- 6. Maintain erosion control throughout entire plat until 70% vegetation has been established including basin.
- 7. Remove all trash and debris from site.
- 8.Be sure that all as-builts are turned in and accepted.
- 9.Be Sure that all punch lists from the bond inspection have been completed
- 10.End section 200 and field inlet 305 needs to have excess silt cleaned out.
- 11. Field Inlet 100 B needs to be graded around the structure.

We do not claim this list identifies all possible incomplete, damaged, or unfinished work - items may have been unintentionally omitted. Omission from the punch list does not relieve the Developer, Contractors, or Engineer from responsibility to complete work in accordance with approved Engineering Plans, Development Plans and Lee's Summit's Design and Construction Manual.
