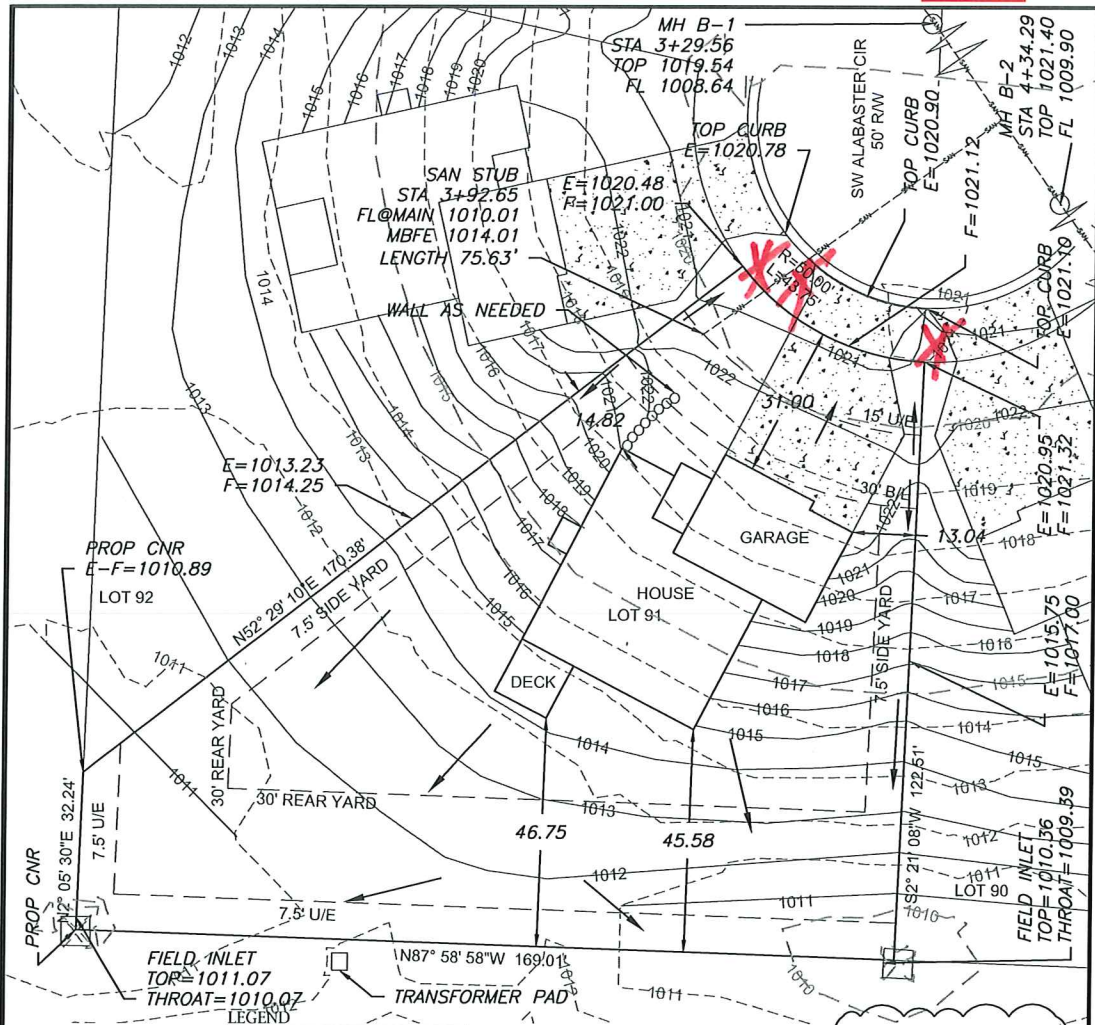

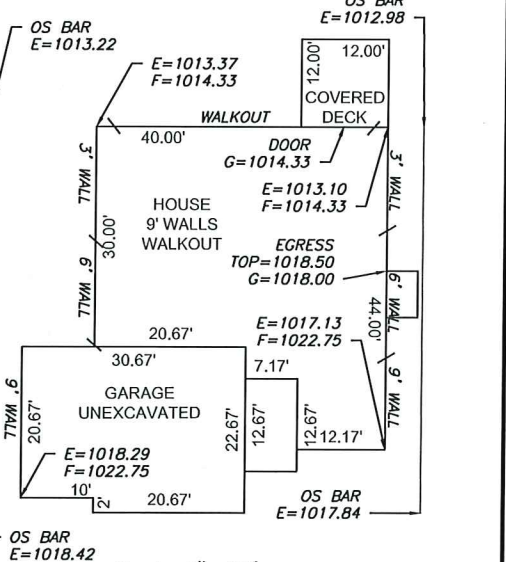

AS-GRADED PLOT PLAN REQUIRED PRIOR TO SODDING



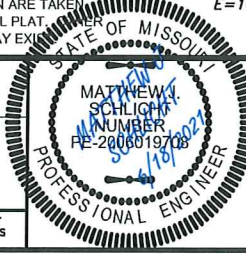
