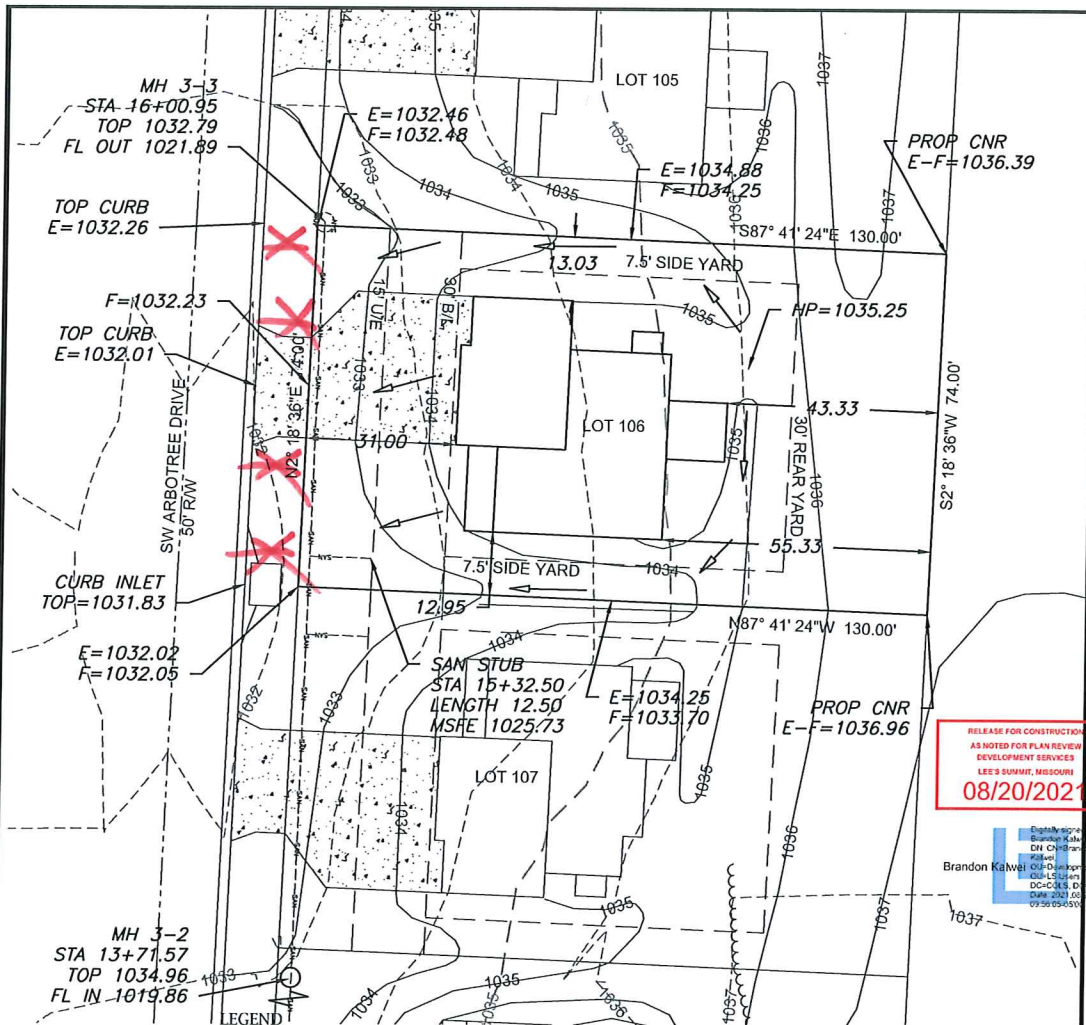

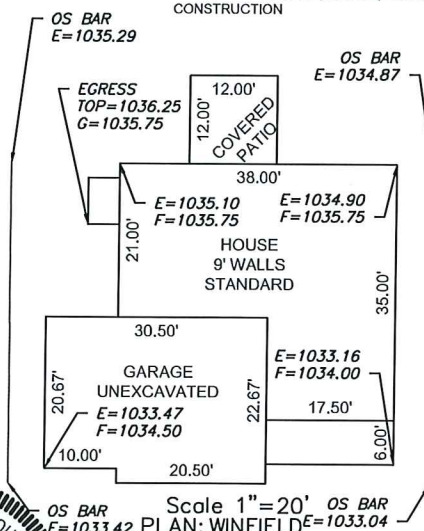

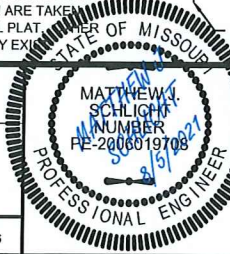
PLOT PLAN - LOT 106
