- 2. Basement egress location(s) and elevation of the lowest adjacent grade must be provided on the plot plan. MISSING ON SOUTH SIDE

- 1. One (1) complete permit application / NEED TO ADD UNFINISHED BASEMENT SQ. FT. TO APPLICATION
- 2. Provide square footage of living area, garage area, unfinished basement area, etc (IRC Section R304) ADD SQ. FT. FOR UNFINISHED BASEMENT AND GARAGE
- 4. Designate locations of smoke detectors and carbon monoxide detectors. (IRC Section R314 and R315) SMOKE/CO NEEDED OUTSIDE OF EVERY BEDROOM

- 5. Provide combustion air calculations and specify transfer air grilles for fuel burning appliances located in confined space(s). (IRC Chapter 17 and Section G2407)
- 6. Provide size, spacing, species, and grade of rafter, ceiling joist materials and ridge and valley members. (IRC Section R802) PLEASE VERIFY HOW ROOF WILL BE CONSTRUCTED, APPLICATION SHOWS NO ROOF TRUSSES, PLANS SHOW ROOF TRUSSES WILL BE USED, WILL NEED TO ALTER APP IF USING TRUSSES

- 12. Identify type of joist package or floor truss package (if used) complete with layouts, fastening details, blocking and bracing requirements and minimum sheathing. APPLICATION SHOWS NO ENG. FLOOR SYSTEM, PLANS SHOW TJI. PLEASE SPECIFY AND CHANGE PLANS OR APP.
