- Wall sign square footage is limited to no more than 10% of the square footage of the wall on which the signs are mounted. According to our plans, the tower element on which the signs are proposed to be mounted is 8.75' wide x 13.75' tall (excluding the pitched roof element), which equals 120.3 sq. ft. This means that no more than 12 sq. ft. of wall signage can be mounted on said wall.
