Access to the required facilities shall be from within the building or from the exterior of the building. All routes shall comply with the accessibility requirements of this code. The public shall have access to the required toilet facilities at all times that the building is occupied.

Action required: Relocate restroom or redesign space to comply. Any new or relocated restroom and/or restroom components must be brought up to all modern codes, including accessibility.
