3. One (1) complete permit application. Plans show covered deck, application does not. Need to have the application revised and resubmitted.

4. Two (2) copies of construction drawings. (Plans to be signed and sealed by an architect or engineer registered in the State of Missouri.) Plans do not have construction address on them.

5. Provide square footage of living area, garage area, unfinished basement area, etc (IRC Section R304) missing garage sq. footage

6. Designate locations of smoke detectors and carbon monoxide detectors. (IRC Section R314 and R315)

7. Provide combustion air calculations and specify transfer air grilles for fuel burning appliances located in confined space(s). (IRC Chapter 17 and Section G2407)

9. Identify roof covering material (IRC Section R905) gives metal and comp roof option. Needs to be decided and put on plans, you can alter the plans if you decide to go another route.

10. Specification of rafter ties or ridge beam design. (IRC Section 802.5.2)

11. Footings, column pads, piers and grade beams - dimensions. (IRC Section R403) not seeing details for covered deck piers and pier pad AA in garage

12. Footings, column pads, piers and grade beams - reinforcement size and spacing. not seeing details for covered deck piers and pier pad AA in garage

13. Identify interior load bearing walls. (IRC Section R602)
