You are instructed to read and to note the following described changes, corrections, clarifications, omissions, deletions, additions, and statements pertinent to the Contract Bid and Construction Documents:

The Addendum No. 1 is part of the contract Bid and Construction Documents and shall govern in the performance of the Work.

Architectural Items:

Item A1: Sheet G-001 (Cover Sheet)

- A. Note change of fire barrier model to UL #U301.
- B. Add separation lines to each demising wall and callout notation for typical fire barrier.
- C. Add Civil sheets and numbers to cover sheet index.

Item A2: Sheet A-503 (Building Details)

- A. Added Detail A1, Fire barrier details and notation for clarification.
- B. Added Detail A5, Standing seam and wall connection for notation and clarification.

Structural Items:

Item S1: General

A. The main exterior canopy column lines shall have both a high and low sloping steel beam with geometry configured as shown in the architectural building elevations.

Item S2: Sheet S-102, (Canopy Foundation and Framing Plans)

A. (Roof Framing Plan) Revise Patio Canopy structure; In lieu of 2x12 wood joists, the exterior canopy roof construction shall be 1.5"x22Ga Wide Rib (Type B) steel roof decking supported by HSS8x4x¼ steel tube joists at 6'-0" OC supported by steel tube beams as currently indicated on plan.

Item S3: Sheet S-103 (Wall Framing Plan)

A. Revised note on (Wood Shear wall Schedule) note to be 5/8" min gypsum board in lieu of ½"min gypsum board.

Item S4: Sheet S-201/202 (Framing Isometric)

A. Revised isometric details to reflect structural changes of canopy structure.
