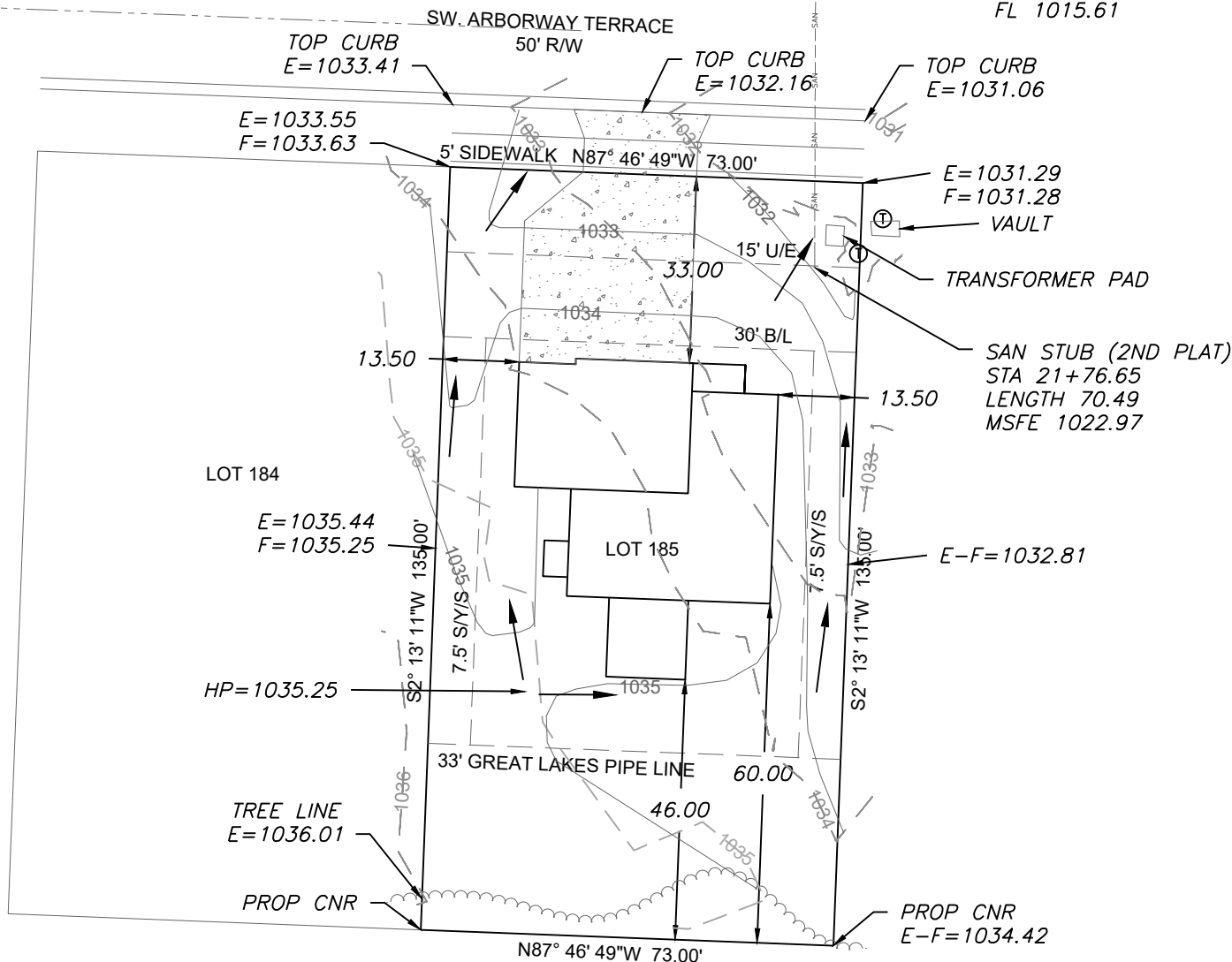

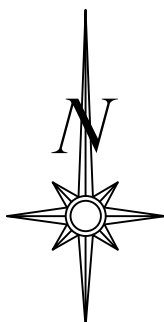

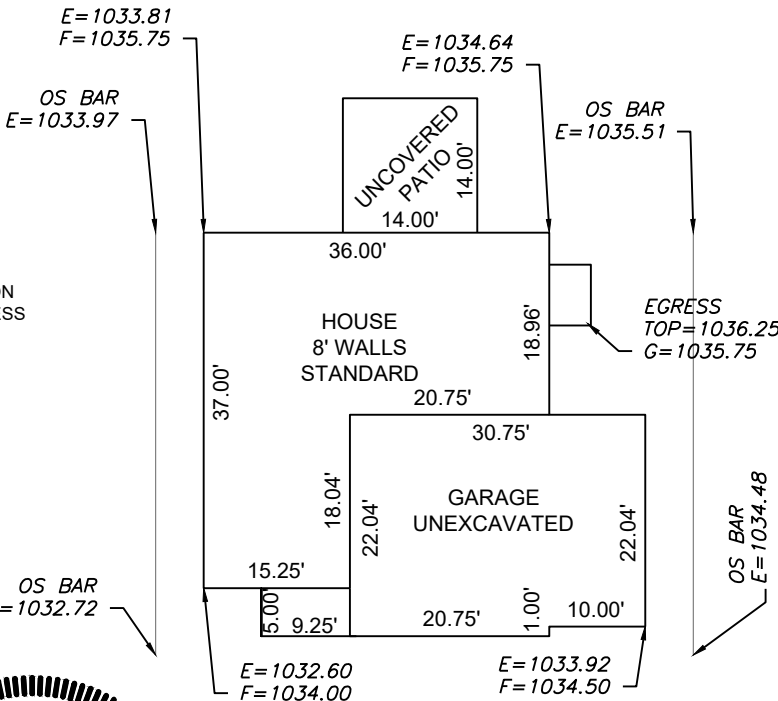

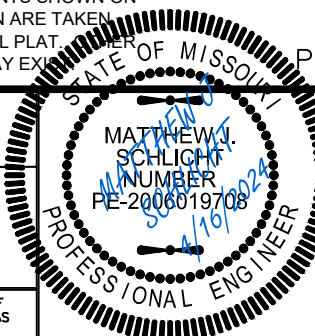


PLAN: BASSWOOD
