1. 2018 IFC 901.2- Construction documents. The fire code official shall have the authority to require construction documents and calculations for all fire protection systems and to require permits be issued for the installation, rehabilitation or modification of any fire protection system. Construction documents for fire protection systems shall be submitted for review and approval prior to system installation.

The automatic sprinkler system shall be extended into the sauna. Provide as-built plans with a NICET stamp. Verified at inspection. Acknowledged, and will be provided.

2. 2018 IMC Section 914 Sauna Heaters.

Provide verification of compliance with:

- IMC 914.4 as concerns controls heat and time controls.

The timer to be set for 1 hour by default. Provide a special sequence button press/hold to get into 4 hour mode. This will keep it in 1 hour mode per notes on sheet A1

The heat controls to provide for 165 degree maximum temperature per notes on sheet A1.

- IMC 914.5 as concerns minimum ventilation.

- A ventilation opening, 4" x 8" located near the top of the door into the sauna room shall be provided per notes on sheet A1

- IMC 914.5.1 as concerns signage A sign shall be provided stating: "WARNING: DO NOT EXCEED 30 MINUTES IN SAUNA. EXCESSIVE EXPOSURE CAN BE HARMFUL TO HEALTH. ANY PERSON WITH POOR HEALTH SHOULD CONSULT A PHYSICIAN BEFORE USING THE SAUNA" per notes on sheet A1. 9/16/2024 - not addressed.
